



## ORDER OF RATIFICATIONS/ACCESSIONS TO THE CONVENTION ON CLUSTER MUNITIONS

*As of April 2016*

The Convention on Cluster Munitions was signed by 94 states when it opened for signature in Oslo on 3 December 2008. On 16 February 2010, only 15 months later, the 30<sup>th</sup> state ratified the Convention, triggering its entry into force on 1 August 2010.

Since the Convention entered into force, it is no longer open for signature. Instead, states that have not signed it must become bound through the process of “accession”. Each signatory state must still ratify the Convention in order to become a State Party.

119 countries have joined the Convention, 100 are States Parties.

Date of ratification or accession is in parentheses. Bold indicates an accession.
